Coming into force

In accordance with Article 1

Transport for London, in exercise of the powers conferred on it by sections 4 and 9 of the Metropolitan Public Carriage Act 1869⁽¹⁾, section 1 of the London Cab and Stage Carriage Act 1907⁽²⁾ and sections 1 and 2 of the London Cab Act 1968⁽³⁾ and of all other powers enabling it in that behalf hereby makes the following Order:—

1 Citation and commencement

This Order may be cited as the London Cab Order 2018 and shall come into force on 6 October 2018.

2 Preliminary

The London Cab Order 1934⁽⁴⁾ (“the Principal Order”) is amended in accordance with the following provisions of this Order.


3 Fares for motor cabs

- (1) Article 40 of the Principal Order shall be amended as follows:-
- (2) At 2(a)(i) for “117.4” substitute “116.6” and for “9626.8” substitute “9561.2”.
- (3) At 2(a)(ii) for “25.2” substitute “25.1” and for “9626.8” substitute “9561.2”.
- (4) At 2(b)(i) for “95.5” substitute “94.8” and for “9645.5” substitute “9574.8”.
- (5) At 2(b)(ii) for “20.5” substitute “20.4” and for “9645.5” substitute “9574.8”.
