TfL randomly selects and monitors vehicles subject to a discount to identify possible fraudulent use. If you persistently fail to pay congestion charges due or attempt to defraud the scheme, TfL may record your vehicle's movements and may disclose relevant details to local authorities and/or law enforcement agencies, to assist in tracing persistent evaders and those committing fraud.
