

Paying the Congestion Charge

Guidance notes for completing this form.

This form is to be used for the payment of a daily, weekly, monthly or annual Congestion Charge, before travelling in the Congestion Charging zone.

It is important that you read these notes carefully before completing the form.

How Congestion Charging works

Anyone, except those exempt or discounted, driving or parking a vehicle on public roads in the Congestion Charging zone between 7am and 6.00pm, **Monday to Friday** (see below for exclusions), has to pay the daily Congestion Charge.

Exclusions

The charge is not applicable on the following days;

- Bank Holidays
- The first 3 charging days (whether or not consecutive days of the week) that follow the 26th December.

You can pay the Congestion Charge beforehand, on the day of travel or the following charging day.

The charge is £8 if you pay by midnight on the day of travel or £10 if you pay by midnight the following charging day (you can pay the following charging day via the call centre and website only).

If you do not pay the Congestion Charge we will send a Penalty Charge Notice of £120 to the registered keeper of the vehicle. As with parking penalties, this is reduced to £60 if paid within 14 days.

Advance payment of the Congestion Charge

You can use this form to pay for you Congestion Charge up to 90 calendar days

in advance of driving in the Congestion Charging zone.

The following standard charges apply. (Please note that discounts are applied when a charge is paid for 20 or 252 consecutive days).

- £8 for a day (1 charging day)
- £40 for a week (5 consecutive charging days)
- £136 for a month (20 consecutive charging days, including a 3 day discount)
- £1696 for a year (252 consecutive charging days, including a 40 day discount)

Please allow 10 days for your payment to be processed.

There is no facility to pay for the previous charging day via post.

Alternatively, if you are a resident within the Congestion Charging zone and you are registered for the residents' discount, you can pay the following discounted amounts.

- £4 for a week (5 consecutive charging days)
- £16 for a month (20 consecutive charging days)
- £201.60 for a year (252 consecutive charging days)

If you drive in the Congestion Charging zone before you receive a letter confirming proof of your payment, you will have to pay the Congestion Charge or you will receive a Penalty Charge Notice.

How to complete this form

Please complete the form in CAPITALS using BLACK ink.

There are several places on the form which MUST be completed, for example:

- Your vehicle registration number
- The start date and duration for which you are paying the charge
- Your payment details

These, and other compulsory items, are marked with an asterisk * and must be completed otherwise the form may be returned to you.

Please ensure that you sign and date the form, or it will be returned to you.

Cheques or postal orders should be made payable to 'Congestion Charging London' and crossed 'account payee'. Please allow 10 days for your cheque to clear with your bank. You can pay by credit/debit card when paying by post. If you wish to do this, please complete section 4 with your card details. We recommend that you do not send cash through the post.

What happens next?

After you have made your payment by post you will receive a letter confirming proof of payment. Please do not assume that payment has been successful until you have received this confirmation. Transport for London cannot be held responsible for postal delays.

Other ways to pay the Congestion Charge

You can pay your Congestion Charge in the following ways:

Call centre - phone 0845 900 1234 and give the operator your details. Or, you can use the automated telephone service, which allows you to make your payments without speaking to an operator.

Mobile phone text messaging - you can register to pay by text message through our web site at www.cclondon.com or by phone on 0845 900 1234. Please remember that you should never text while driving.

You are also able to pay your Congestion Charge at the following sales and service points where you see the Congestion Charging sign.

Selected petrol stations - in the Greater London area.

Selected retail outlets - throughout the Greater London area, Home Counties and nation-wide.

Caution

Payment at the discounted rate is only valid for **residents within the Congestion Charging zone who are holding a resident's discount eligibility letter**. TfL take fraud and misuse of all discounts very seriously and will be carrying out verification of the information supplied including residential and on-street inspections and checks.

Do not select to pay the charge at the discounted rate unless you have qualified for the 90% discount from Congestion Charging.

TfL will prosecute those found committing fraud.

Data Protection Statement

Transport for London (TfL) and its agents will process your information for the operation of the Congestion Charging scheme. Processing will include the use of cameras to record data. Your information may be disclosed to, or requested from, the Driver and Vehicle Licensing Agency (DVLA), local authorities, law enforcement agencies and other organisations for the administration (including verification of discount entitlement) and enforcement of the scheme; the prevention and detection of crime and protection of public funds.

TfL randomly selects and monitors vehicles subject to a discount to identify possible fraudulent use. If you persistently fail to pay Congestion Charges due or attempt to defraud the scheme, TfL may record your vehicle's movements and may disclose relevant details to local authorities and/or law enforcement agencies, to assist in tracing persistent evaders and those committing fraud.
