



Resources:

3 General Auditors, 1 Security Auditor and 1 IM Manager joined in period Q4 with 2 Managers, 1 General and 1 Security Auditor leaving. We finished the year with 7 vacancies.

Performance against Budget:

Our total expenditure for the year was £5,334,000, which was £89,000 below the budget of £5,423,000. Significant variances to note are:

- A £262,000 overspend on our co-sourcing contract with EY;
- Additional HR recharges of £60,000 reflecting higher level of recruitment activity than had been expected at the start of the year;
- Unbudgeted costs of £47,000 for our office move during the year.
- These overspends have been offset by underspend on salary costs as a result of us having below budgeted headcount during the year. Training costs were also below budget.
