# 1 Summary

1.1 To report to the Committee on fees billed by KPMG for non-audit services in the period between 1 April 2015 and the date of signing the financial statements (10 July 2015).

#### 2 Recommendation

2.1 The Committee is asked to note this report.

## 3 Background

- 3.1 Under TfL's policy on external audit services KPMG is required to report to the Audit and Assurance Committee every six months on fees billed for non-audit services. KPMG's last report, which covers the period from 1 April 2015 to 10 July 2015 (being the date at which KPMG signed the financial statements), is attached for the Committee's review.
- 3.2 The provision of commercial and accounting advice in relation to TfL advertising contracts; and the provision of strategic advice in relation to the Silvertown Tunnel were discussed with the Chair of the Audit and Assurance Committee in advance of KPMG bidding for the respective assignments. The initial quote in respect of the strategic advice on Crossrail 2 was estimated at £130,000 – below the £150,000 maximum amount allowable without prior agreement of the Chair of the Audit and Assurance Committee. Advance agreement from the Chair of the Audit and Assurance Committee was therefore not requested. Subsequent scope changes resulted in the final fee of £190,619 exceeding expectations. No other individual non-audit assignment for the Group exceeded maximum amount allowable without prior agreement of the Chair of the Audit and Assurance Committee. All potential assignments were however discussed with the Chief Finance Officer in advance, and the process set out in the Policy on Audit and Non-audit Services was followed.
