METROPOLITAN PUBLIC CARRIAGE ACT 1869

The London Cab Order (No. 2) 2023

Made Coming into force 10 November 2023 In accordance with article 1

Transport for London, in exercise of the powers conferred on it by sections 4, 6 and 8 of the Metropolitan Public Carriage Act 1869¹ and all other powers enabling it in that behalf, hereby makes the following Order: —

1. Citation and commencement

- (1) This Order may be cited as the London Cab Order (No.2) 2023.
- (2) Article 3 of this Order comes into force on 1 October 2025.
- (3) Article 4 of this Order come into force on 26 February 2024.
- (4) Article 5 of this Order comes into force on 1 July 2025.
- (5) Article 6 of this Order comes into force on 1 July 2024.

2. Preliminary

The London Cab Order 19342 ("the Principal Order") is amended in accordance with the following provisions of this Order.

3. Applicant for Cab-driver's licence to have passed SERU

The following paragraph shall be added as paragraph 24A-

"24A The safety, equality and regulatory understanding requirement

- (1) A cab-drivers' licence shall not be granted to a person who has not passed the safety, equality and regulatory understanding requirement.
- (2) The safety, equality and regulatory understanding requirement is that the applicant has an understanding of the following matters: -
 - (a) obligations under:
 - (i) the Metropolitan Public Carriage Act 1869;
 - (ii) this Order; and
 - (iii) any other enactment, including the Equality Act 2010,

that are relevant to persons granted a cab-driver's licence;

- (b) policies and guidance issued by Transport for London or other persons or entities that are relevant to persons granted a cab-driver's licence;
- (c) the particular needs of passengers that arise because a passenger has (or may have) a protected characteristic within the meaning of Chapter 1 of Part 2 of the Equality Act 2010;
- (d) protecting children and adults at risk from harm and abuse;
- (e) passenger and driver safety; and
- (f) road and vehicle safety,

as set out in the Handbook.

- (3) Applicants must satisfy Transport for London of their ability to meet the requirement in paragraph 24A(2) by satisfactorily completing a test conducted by or on behalf of Transport for London concerning the matters set out in the Handbook prior to the grant of any licence.
- (4) In this paragraph, "the Handbook" means the Taxi Driver's Handbook published online from time to time by Transport for London.".

4. Cab-drivers to maintain subscription to DBS Update Service

The following paragraph shall be added as paragraph 25B-

"25B Cab-drivers to maintain subscription to Disclosure and Barring Service ("DBS") Update Service

- (1) Subject to sub-paragraph (2), it shall be a condition of a cab-driver's licence granted after the coming into force of this paragraph that a cab-driver maintain a continuous subscription to the DBS Update Service.
- (2) A cab-driver who is unable to comply with sub-paragraph (1) must provide a further Enhanced DBS check upon request from Transport for London or its authorised service provider.
- (3) In the event of
 - i. a cab-driver ceasing to be registered with the DBS Update Service; or
 - ii. a status check of the DBS indicating that the status of a cab-driver has changed following the date of issue to the cab-driver of a DBS certificate,

then the cab-driver must provide to Transport for London a further Enhanced DBS check certificate upon request from Transport for London or its authorised service provider.".

5. Cab-drivers to ensure display of prescribed signage

The following paragraph shall be added as paragraph 28B-

"28B Cab-drivers to ensure prescribed signage is displayed

A cab-driver shall ensure that the cab being operated is displaying signage which is prescribed for display inside the cab.".

6. Cab driver's arrest, charge, caution or conviction to be notified.

The following paragraph shall be added as paragraph 32A-

"32A Cab-driver's arrest, charge, caution or conviction to be notified

If during the currency of his licence the holder of a cab-driver's licence is arrested and released, charged, cautioned or convicted, he shall within 48 hours of the date of such event, give Transport for London notice containing details of the arrest and release, charge, caution or conviction as the case may be.".
